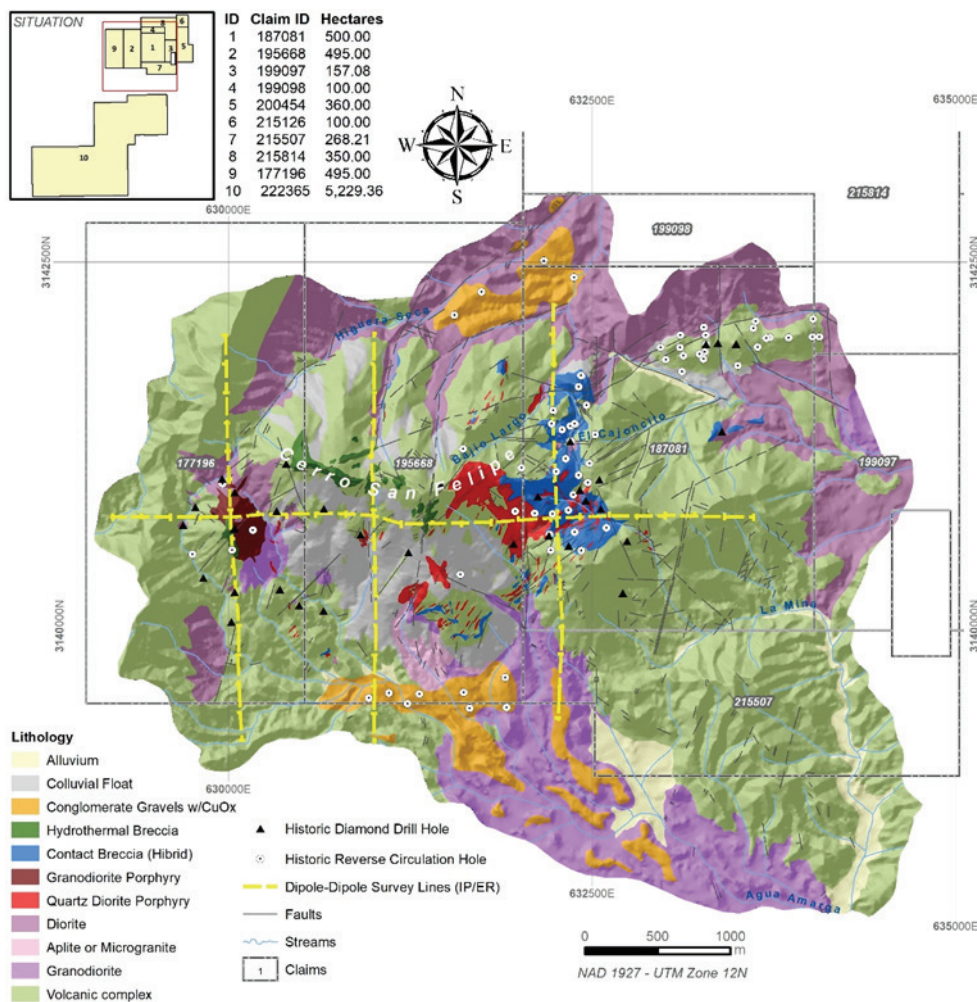


Figure 1 shows the geological map and arrangement of the historical data in the project areas.
